Reviewing the tariff and making an increase of fares will have a general impact on the cost of taxi journeys across the district. Taxi fares have a direct impact on the taxi drivers, operators and proprietors of licensed vehicles by way of the remuneration provided through the journeys taken by the public and there is a similar impact on individuals and businesses using taxis for these journeys which may be pleasure or business related. The impact of the proposals will depend on any increase approved. Should the Council set the fare too low this may adversely affect the supply of taxis in the area. Whilst setting the fare too high may have a negative impact on the vulnerable users of this essential service, for example protected groups including the disabled who rely on taxis as a principle form of transport. Basing any increase in an educated and methodical manner and upon CPI data from the Office of National Statistics will enable a proportionate response to the above issues.
