Financial Assistance Policy for the Better Care Fund

Brief description of proposal to be assessed: The introduction of "Discretionary Disabled Facility Grants" (DFG) and the Housing Financial Assistance Policy allows for DFG funds, which sit within the Better Care Fund (BCF), to be used more flexibly. The policy allows discretionary DFGs to be used to provide assistance to help a greater number of residents remain living in their own home independently and safely. DFGs are used to help disabled or older residents living in the private sector make adaptations to their home, so that they can continue living there. Local authorities are required to facilitate mandatory DFGs where certain conditions are met. These can include widening of doors, installing ramps and improving access to shower facilities. In addition to mandatory DFGs, local authorities have discretionary powers to award grants and use funding for a wider range of resources, works and adaptations to help reach a greater number of residents. Local authorities must publish a policy in order to use these discretionary powers to spend DFG money more flexibly. It must be noted that mandatory DFGs are a statutory obligation and as such must take precedence over discretionary grants. NDC is being awarded a BCF grant of £1,510,574 for 2021/22, an uplift of £532K. The proposal allocates this funding to specific interventions in the Council's financial assistance policy.

The increase in funding will help a greater number of residents remain living in their own home.
