Weekly Trial - Cancellation

**Brief description of proposal to be assessed:** It is proposed that we stop collecting black bins every 3 weeks and return to collecting fortnightly, bringing them in line with the rest of the district.

**Brief description of the anticipated outcomes of the proposal:**

## **Impact:**

**Benefits:** By returning the residents in the trial area to a fortnightly refuse collection, all\* residents within the North Devon Council boundary will be receiving the same level of service.

There won't be the opportunity for residents to claim they are being discriminated against because of the location they live in (the trial area).

The Council tax that residents pay won't come into question, as they will be receive the same level of service as the rest of the district.

**Negative Impacts:** This will mean a change in collection frequency for 3,500 residents, which is something new they will have to get used to, but it should please most residents that they will be receiving more frequent collections

The amount of general waste generated may increase by returning to a fortnightly collection frequency.

Residents may be unhappy that they will be limited to how much recycling they will be able to present, but it will be in line with the rest of the district.
