Fee

There is a fee of £65.00 per application, plus a fee per property:

The price per units depends on the number of properties in your application

1 to 10 Units - £10.25 per Unit 11 to 100 Units - £5.25 per Unit 100+ Units - £1.30 per Unit

Examples:

1 Unit: £65 Application fee + £10.25 x 1 = £75.25 9 Units: £65 Application fee + £10.25 x 9 = £157.25

49 Units: £65 Application fee + £10.25 x 10 + £5.25 x 39 = £372.25 100 Units: £65 Application fee + £10.25 x 10 + £5.25 x 90 = £640.00

109 Units: £65 Application fee + £10.25 x 10 + £5.25 x 90 + £1.30 x 9 = £651.70
