For example, we cannot see if you are eligible for a tenancy or check that an application is not fraudulent without being able to verify your identity. Where information relates to household members, it is our legitimate interests to know who is applying for housing. We will use this information to check that accommodation offered is adequate for your household's needs, and to ensure that the local community will have quiet enjoyment of their homes.

How will your personal information be used?

The 10 local authority partners in Devon Home Choice will use your information for the following purposes:

- To decide if you are eligible to be join the Devon Home Choice register
- To assess your application and give you priority for housing, in line with the Devon Home Choice policy. This may include sharing information with medical and housing professionals as part of a Health & Wellbeing Assessment panel or to assess your housing needs.
- To provide you with advice and help about your housing options
- For administration and auditing purposes to ensure that everyone is treated equally
- To provide reports
- To plan for future housing needs. This may include sharing data with Devon Communities
 Together (on behalf of the Devon Rural Housing Partnership) and contacting you as part of a

- To seek your views

Devon Home Choice partner landlords will use your information for the following purposes:

Alternatively you can complete this application form and return it, with any additional information requested on the form, to your local housing team.

How applications are assessed

All applications to join the Devon Home Choice register will be assessed and placed in 1 of 5 priority bands. This will be based on our assessment of your housing need, and whether or not you have a local connection to Devon.

The 5 priority bands are:

- Band A: Emergency Housing Need
- Band B: High Housing Need
- Band C: Medium Housing Need
- Band D: Low Housing Need
- Band E: No Housing Need

Please note that Exeter, Teignbridge and Torbay councils do not register households assessed to have no housing need (Band E).

How homes are advertised

Council and housing association homes available to let in Devon are advertised each week:

- On www.devonhomechoice.com
- On the Devon Home Choice App for Android and Apple phones
- In a newsletter that is available in a variety of locations

Homes are advertised from 12:00am on Wednesday to 11:59pm the following Monday. No homes are advertised on a Tuesday.

The adverts tell you the landlord, location, size, rent and other features of the home.

The advert also tells you if there are any special requirements that the applicant must meet. For example any minimum age if it is older persons accommodation, or whether a local connection to a particular area in Devon is required.

Where homes have been adapted, adverts will make clear that priority will be given to applicants who have a mobility need or disability.

Bidding for homes

Once your application has been accepted onto the Devon Home Choice register you can tell us which homes you would like to be considered for. This is called bidding. Bidding does not mean that you will part with any money.

You can bid for up to 3 homes each week:

- On www.devonhomechoice.com
- On the Devon Home Choice App for Android and Apple phones
- · In person at Council offices

In order to bid for homes you will need:

- Your User ID (Application number)
- Your password.

You can only bid for homes that match your household needs. For example, if you only need 2 bedrooms you will not usually be able to bid for 3 or 4 bedroom homes.

- Under Devon Home Choice each of the following are assessed as requiring a separate bedroom:
- People living together as a couple
- Other adults, aged 16 years old or over
- 2 children or adolescents under 16 years old of the same gender
- 2 children who are both under 10 years old regardless of sex

Any exceptions to these rules will be clearly set out in the advert for a home.
